Description:

This raffle is conducted by the American Cancer Society, Inc. (ACS) and is governed by all applicable federal, state, and local laws.

Funds raised will benefit the mission of the American Cancer Society, a 501(c) 3 organization.

The winner will be selected by drawing during the 2022 Tyler Cattle Barons' Gala on Saturday, June 11, 2022 at approximately 9:00pm CT, at the Texas Rose Horse Park 14078 TX-110, Tyler, TX 75704.

Each entrant represents that they meet all of the stated eligibility requirements and agrees to be bound by these official rules.

To enter:

Tickets are \$100 each.

Tickets are available for purchase at Hall Buick GMC located 3010 S SW Loop 323, Tyler, TX 75701 during the raffle ticket sales until June 4, 2022 until 5:00pm CT. Tickets may also be purchased at the Tyler Cattle Barons' Gala at the Texas Rose Horse Park 14078 TX-110, Tyler, TX 75704 on June 11, 2022 until 9:00pm CT.

Purchases may be made by cash, credit or debit card, or check. Checks should be made out to the American Cancer Society. All entrant information should be completed upon purchase of ticket(s).

Each entry has a separate and equal chance to win. Six hundred (600) tickets will be printed and available for sale.

Prize:

The prize is a 2022 GMC SLT Sierra Crew Cab Special Cattle Baron's Edition, 5.3L V8 Engine, 10 Speed Automatic, Custom Leather Interior, 13.4" Premium Infotainment System, 6" Oval Chrome Assist Steps, Special Badging and Embroidery. This prize was generously donated by Hall Buick GMC. This prize has a Factory MSRP of \$56,975.

There is no alternative cash prize option. Prizes may not be substituted or transferred until after award.

Taxes and other fees:

Winner will be responsible for applicable local, state, and federal sales and withholding taxes, licensing, and other transfer costs and all expenses associated with ownership.

Prior to award of vehicle, winner must complete an IRS form W-9 and other related documents, provide picture identification, and pay ACS all applicable withholdings with guaranteed funds (e.g., cashier's check, money order, etc.).

The Federal withholding tax on a prize with a fair market value of \$56,975 is \$13,674 (24%). State and local tax withholding will be calculated and withheld based on winner's legal residence and the associated state law. There is no state withholding required for Texas residents.

Winner is also responsible for any applicable sales tax, license, documentation preparation charges, smog fees, other DMV and transfer fees, as well as cost of ownership.

The winner will receive a W2-G in February 2023 to complete their annual tax returns.

The IRS has taken the position that raffle ticket purchases are not gifts and therefore do not qualify as a charitable donation. Entrants should check with their tax advisor regarding tax components of ticket purchases or taxes associated with raffle winnings.

Participation/Eligibility:

Entrants must be 18 or older to participate in the raffle or win a prize.

Society staff and volunteers involved in the raffle and their immediate family members may not participate. Society staff is defined as anyone employed in any capacity by ACS or the ACS Cancer Action Network. Volunteers involved in the raffle are defined as ACS event chairs and committee members; volunteers not involved in raffle operations - who sell tickets - may participate. Additionally, associates and immediate family of Hall Buick GMC and its affiliates may not participate.

Immediate family members of staff, volunteers, and associates and affiliates of Hall Buick GMC include spouse, domestic partner, mother, father, siblings, children, grandchildren, and grandparents.

Selecting the winner:

A representative of Hall Buick GMC will draw the winning ticket randomly from a receptacle during the Tyler Cattle Barons' Gala on June 11, 2022.

The winner does not need to be present to win. If the winner is not present, they will be contacted using the contact information provided on the winning ticket stub. Entrants must fill out all required fields on the ticket stub.

Prize acceptance:

A prize is accepted when a winner signs the IRS Form W-9 and other appropriate forms, provides identification, remits withholding taxes, and takes possession at the dealership.

If a prize winner does not accept prize within 30-days, the prize will be forfeited, and awarded to the back-up winner who will be drawn in the same manner as the winner the night of the Cattle Barons Gala.

If a winner declines the prize, they must sign a Raffle Prize Disclaimer form.
